**Document to be issued by Penn State:**

- I-20 (for F-1 student visa). My primary source of funding will be a Penn State assistantship, personal funds, or funds from family or friends. (F-1 dependents will be issued F-2 visas.)
- DS-2019 (for J-1 Exchange Visitor/Student visa). My primary source of funding will be US or home-country government or an international organization. (J-1 dependents will be issued J-2 visas.)
