Conflict cycles: Group membership, policy diffusion, polarization, and conflict in the international system. I argue that state interactions over the social network of the international system: (1) spread political institutions between

and induce cooperation among states, (2) create cooperative communities of states, or groups of states with homophilous political institutions that are less internally conflictual, and (3) violent conflict between these cooperative groups of states recreates the social network of the international system. *In preparation.*

This project uses large language models to generate synthetic text at different literacy levels to assess whether lower literacy rates produce slower predicted police response times.
